## **Services narrative**

What were the goals of the professional learning? How did you work with the school or system to determine the goals and progress monitor for them throughout the engagement? (Limit 200 words)

The guiding questions for the professional learning series were: (1) What do we want math instruction to look like, sound like, and feel like? (2) How might a high-quality, standards-aligned instructional resource equip us to reach that goal? Prior to developing these guiding questions, CESA 2 Consultants connect with district leaders about what their goals are, what does current reality around mathematics instructions look like, and where they would like to be. This initial conversation paves a path for our goals and what the professional learning experience will look like. After each professional learning session, participants are asked to complete an exit ticket that helps inform the CESA 2Consultants. Throughout the entire

professional learning process, CESA 2 Consultants and checking in with administrators and district leaders to ensure we are progressing toward our goals.
